They definitely minimize the extent

Many schools seem to take the approach, "it doesn't happen here"

Yes but heads in the sand

yes, but schools tend to focus on those they know are exhibiting warning signs rather than universal approach

One of our local HS invited our agency in to do a support group for students who had been victims.

definately reactive not proactive

Our middle schools are more willing than the HS to invite us in, we have a standing invitation with middle schools for prevention, but the HS is hard

They don't see the connection between victimization and ability for a studentd to function in school.

Nell Myhand: How Are Schools Using Federal, State and Local Policies in TDV Prevention?

Schools in RI have to report to the health dept about whether or not they have complied, but there is no real evaluation.

Programming varies greatly by district though.

FL - requires DOE to develop a model policy; requires school personnel training. FCADV working with DOE

Virginia doesn't even have to provide family life

Some of our local schools are using Safe Dates

Modified Safe Dates with other elements

Contra Coasta is using Safe Dates as well as expect respect..

We just started to implement Safe Dates, we also do a Bystander Prevention model focusing on peers lead discussions about how to prevent

we are in the schools but it has been an uphill battle

4th R is being used in some states

We are using using Safe Dates as well as MVP in Wilmington, NC

RI DOH adapted 4th R and just put out their curriculum. I don't know if any schools are using it yet.

We are also a DELTA Project and have been in schools for years. We start with 5th grade, follow students to middle school, and then thru high school via Violence Prevention Clubs.

Our DELTA project is in the elementary school and that has been a little easier

We do two sessions in middle and high school. We also do a more in depth 5 week Teens Preventing Dating Violence class in the summer and have a TPDV group during the year.
