From your experience, what links do you see between child maltreatment, sexual violence and intimate partner violence?

Oppression, root causes

NSVRC study of revictimization rates is another good study that shows the links. difficulty in getting accurate rates, under-reporting

And here's the NSVRC's child sexual abuse prevention resource packet

Homes with IPV having a higher rate of maltreatment of children and sv

Abuse or neglect as a child means greater vulnerability to further abuse as an adult shared norms, risk/protective factors

Rates of adolescent perpetrators who were victimized as children -studies show 40 to 70%

Revictimization

Too much pride within a family or community.

I think they are associated across the board because I work with children in the school systems and faith-based organizations so there is a lot DFCS involved more than I remember in the last 10 years.

Increase in perpetration by those who've suffered abuse.

Intergenerational, working to reframe from individual issues to issues that can be addressed at the community level also

EU Commission Risk Factors for Perpetration of abuse shows risk factors across the ecological model for various types of violence

drug abuse

D&A abuse and lots of DV cases

How do you use the best available research evidence to influence your decision making?

Good question. I bet a lot of folks are having to think hard on this one. Me too. for funding proposals to support existing programs

Was the research done with people similar to those I want to serve?

clinical practice interventions; educational instruction

APA Ethical Guidelines, NOHS Guidelines, SIOG Guidelines. Ethical Decision Making

We use it to inform changes to programs, especially if it mirrors our experience in the field.

To provide justification for new policies or programs- helps the "big wigs" to understand and give the green light to programs we feel strongly about

Does it work along with the Deliverables

I am usually asked to summarize the research and present in digestible formats to direct service providers.

To anticipate outcomes.

Use research from many different sources... present to stakeholders for review, discussion and then decisions on direction

Being a public health NERD, I like thinking about Hill's criteria for causation

If the evidence is well-established in other fields, we apply it to sexual violence activities & subgrantee guidelines.

Funders, legislators always want proof

Socio-ecological model

Share your experiences when you have used contextual evidence in decision making

I've used contextual evidence in working with sexual assault in south boston, mass

With risk/protective factors and multiple communities. Can further define them, analyze if appropriate...

Community assessment allows for input of community perceptions of issues as well as program/activities implemented thus far in our area

What kinds of things in your experience have helped to make decision making processes successful?

Any advice for working with folks who may be hesitant to use evidence?

Buy in to the decision would appear to be greater by detailing in this manner.

We are controlled by what funders have already pre-determined they want to fund. If a funder wants a particular evidence based model to be used, and if they have already determined how the program is to be implemented, we cannot get funding unless we follow procedures.

Hey Ashley - i just saw your question... don't be scared! And call your TA provider or the PrevenConnect staff!

This prevents us from modifying the program to meet the particular needs of our community

Using contextual and experiential evidence can help with youth programs since research can take so long to prove a program effective and youth culture changes so quickly.

We've experienced that too Cheryl, where an approach is evidence-based for a certain population, but not the one we work with.

Once it's "approved" to use, nobody wants to change it, even if it doesn't work.

Regarding finding peer-reviewed articles, I've looked at PubMed
