overall feelings of helplessness and hopelessness

LOW SELF ESTEEM, LOW INCOME

helplessness and hopelessness

fear

Substance use and undiagnosed mental health issues

When there is no hope for escape, suicide seems to be the best option for some of our survivors

I think substance use/abuse is also needing to be included here...

fear for self, finances, children, family, security

in addition to what Alyson said, feelings of worthlessness

80 percent of our female college students who attempt have had sexual assault hisotry

child exposure to dv and risk of suicide

LACK OF RESOURCES OR LACK OF KNOWELEDGE OF SERVICES

PTSD from SV contributing to suicidal behavior

not feeling 'good enough'

trauma -> mental health -> suicide risk

In rural areas, there is also a generational component. You can only do what you know.
