stages of development and emphasis on shifting perspectives (adult to child) Single greatest risk factor for sex abuse = age. Wow.

This shows that sex ed needs to start early. PARENTS need to know this information. self stimulation in preschools is for self comfort difference in terminology-depending on age of child Great info!! Importance of language and our responses to sexuality. This is great info for all parents/caregivers

the lack of penetration behavior as part of the normal preschool exploration Supervision guidelines are very helpful

Age, risk factor - adult supervision and what that means - excellent. No penetrative behavior

the difference between self-stimulation and masturbation behaviors.

self-stimulation vs. masturbation was very helpful as this comes up a lot!!

Preschoolers don't maserbate it is self-stimulation for comfort not attaching adult meanings to children's behaviors

Unfortunately a lot of schools don't include a lot in their curriculums because they do not want to lose state funding for not having an abstinent-based curriculum

In the community prevention education work I do I have found it helpful to use promo language initially your listener can process - i.e. our program is designed to change how adults understand and respond to older youth and adults communicating and acting in a sexually inappropriate way with children.

Have their been barriers (due to confidentiality) connecting with perpetrators' parole officer or program treatment providers? How have you worked through the barriers?

know that struggle for getting into classrooms all too well. We've found some ways to get around that, but in looking at how to get this information to parents, it seems like PTAs would be easy-access gathering places.
