- Is it that food and housing insecurity is a predictor or vice versa? How do you test to make sure?

- Do you have reason to believe that this significantly lower percentage of men reporting IPV related impact is due to reluctancy to report?
- Or rather, why do you feel there was a significantly lower amount?
- The numbers for accessing advocacy/crisis services is so low which is very telling

- Are we shaping hotline access adequately toward tapping into men's apparent needs, e.g not being able to get his mind off of a particular woman?
- These could be same sex couples as well.
- Do we have a comparable study for rates of IPV and SV among teens up through age 18?
- did it factor out time missed from work or school as a result of being arrested as an alleged perpetrator for men who self-indentied as victims?
- During data collection, were there interviewers using Spanish and other languages with informants?
- within the survey, was there a question about mental health issues such as addiction to drugs or alcohol, and/or other mental illness?
- Is it possible that lower rates of IPV among API persons was due to lack of translators?
- this is very informational and helpful
- What findings do you feel are important for your work to address intimate partner violence and sexual violence?

- This data begins to get to the differential impact of IPV. The huge limitation is context.
 And, the context is decisive.
- less than half victims obtain services maybe more better ways of advertising available services to reduce this number
- I feell that this is helpful and useful for the black community that I'm apart and what we need to focus on in our church and community
- The need to differentiate offenders and risk factors
- wondering also about specific numbers for college students?
- Interested to see if advocate service and housing were sought and not provided.

- Discovering how much a "disclosure" can make a difference builds the case for encouraging more health care providers, friends, family to be involved.
