- SARTs address the issues surrounding adult sexual violence in a community. Most are
 made up of law enforcement, commonwealth's attorney's office, sexual violence crisis
 center, and hospital that does PERKs.

- DV and SO problems, by their nature, require the collabotration of all perspectivesprevention, enforcement, rehabilitation, supprt, etc. No one person/agency can ever possess ALL of the answers. If they did, we could simply blame them for everything.
- I really like the framing of engaging at the first sign of risk, as opposed to at the first sign of abuse
- I find the more you unpack the issue the more complicated it gets. Same with health equity and the social determinants of health.
- question: first sign of risk vs. universal programming/intervention?
- what was the guiding question for the focus group?
- We're taking a place matters approach and trying to work on one community at a time to identify gaps in services and what their needs are.
- This is also a good example of how assessments don't have to be terribly difficult and are very helpful.

- Also, data and evaluation is an important role for county government. As you can
 imagine, the capacity for capturing data and evaluation varies, so counties can play a
 big role in working cross agencies and community partners to gather data and stats and
 reporting out in digestable formats.
- I'm curious as to what other data organizations would be looking at other than dv/sa if they went to a government agency for stats.
- What are you requesting/what do you think is important to gather?
- Or rather, what other information do you find useful to you for the SA/DV nonprofit organizations?
- for us we began with criminal justice data from Law enforcement, DA office, etc. to get a extent/prevalance, but we recognize that just reflects reported and not everyone who experience report.
- So we're looking at county wide health assessment surveys that include a DV question.
- There's also a lot of data available on the risk and resilience factors for SV and DV, which is how you're able to "intervene at the first sign of risk" per one of the goals

- Youth Risk Behavior Survey (YRBS) is a great tool that looks at risk and protective factor data. And the Behavioral Risk Factor Surveillance System (BRFSS) also has some useful data for adults only.
- People/victims are far more receptive to educational and support programs when law enforcement demonstrates it's own committment to a solution to the problems of DV. In Pgh, a partnership of the Court, the DA's Office, the Probation Office, and the primary DV agency has not only impacted offenders, but victims as well. This cooperation led to police officer training conducted by the DA, Probation and DV, and ultimately to the inclusion of a lethality assessment tool that is used on site. ALL of this together, as well as the enjoining of DHS, has substantially improved community education and awareness, and to improved victim safety.
