MS: I like the public health approach because it opens this field up to everyone, not just folks who are involved in the field of work

MW: Involving all systems in prevention

SG: population impact

EB: comprehensive strategies across the SEM

MM: Using public health methods and theory to prevent violence, i.e. SEM, Risk and protective factors

RB: inclusive of many programs

ML: Saving lives,. Yes

SF: Looking at the higher level institutes and how to implement solutions from the top down as well as bottom up

JD: Primary Prevention at all levels!

GS: Addressing the social determinants of health and community assets instead of just individual actions

AKJ: I think about what can we do that will have the most impact on the largest amount of people -- that means we need many strategies working across the spaces we exist and move through

YN: holistic and collaboration from many fields

AF: addressing the intersection of various cultural, societal, and interpersonal factors that influence our understanding of sexual/ domestic violence and shifting from it being an "interpersonal issue" to a public health crisis which can impact every community.

GG: the public health approach involves looking at every level with a population based focus.

RJ: Yes it resonates. A public health approach defines the problem, in this case violence, and identifies risk and protective factors for community strategies, while recognizing the impact of the social determinants of health and health equity. At the simplest level, violence is a health inequity, and the intersection between racism and violence cannot be denied.

NB: Recognizing the common risk factors of multiple forms of violence

AK: @Natalie yes

EH: Absolutely...risk and protective factors.

DD: I am seeing a huge change in funded partners over the next couple of years due to the community level work. Many partners are used to working at the individual and relationship level and may not have the relationships or opportunities s to move to the next level. This also means letting old partners go which is easier said than done.

DD: I've been wondering why it has been so difficult trying to implement this with our funded partners.

AKJ: I think one thing to keep in mind is that we need to continue to do individual work *and* also move into the outer layers

AKJ: so that way we are being comprehensive in our efforts

DD: I don't feel this is realistic for small states and keeping with over 50% of strategies

DD: community strategies

CY: Yes, folks do deeply value the individual level work, and we've felt really successful in getting folks fired up about the potential impacts of community level solutions. Creating protective environments that prevent multiple forms of violence and also support all of us in having thriving lives.
