LMcG: Trim trees and bushes to eliminate hiding places

CT: Bartenders bystander intervention training, campus escorts

CH: increased cameras and lighting in both indoor and outdoor places

RS: additional lighting

SO2: A mirror under a stairwell where kids gathered to exchange pot made the space safer since it was no longer hidden

JR: enhance self-awareness/protection education AND the uses of "NEVER go out alone"

CL: I think that promoting pro-social behaviors is part of changing the environment. Changing norms, bystander intervention, rising up protective factors, not just risk reduction.

TV: Great point, Caitlyn! That ties to the social norms piece of situational prevention, too

LMcG: I love it - very practical! Thank you

TR: We fund a local community college to implement sexual assault prevention strategies. One of their objectives is to strengthen their collaborations between the Health and Wellness Center and Office of Community Standards
